In line with <u>Standard 7</u>, all Church Authorities are required to undertake an annual self-audit and inform the NBSCCCI **by end January 2017** that this has been complete. The NBSCCCI will reference the number of returns received in its annual report in May 2017.

The NBSCCCI will produce an App in the coming months which will contain *Safeguarding Children: Policy and Standards for the Catholic Church in Ireland 2016,* Guidance and all relevant forms. Details as to how to download the App will be forwarded in correspondence to Church Authorities once the work on the App is complete.

The following training courses are now available for booking:

#### 08/02/2017- Role Specific Training for Support People

#### 25/02/2017(and additional dates)- Train the Trainers Course

This training is only for those wishing to become registered as trainers for 3 years with the NBSCCCI. The training will be delivered over 5 days and structured as follows:

- 25/02/2017 and 26/02/2017 (both days starting at 10:00 and finishing at 16:00)- context, group work skills and facilitation skills
- 11/03/2017 and 12/03/2017 (both days starting at 10:00 and finishing at 16:00)- delivering the safeguarding children programme
- 01/04/2017 (10:00 until 16:00)- assessment of each trainer by a tutor from the NBSCCCI and their peers.
- Additional Date- Final assessment of the trainer in their local Church body, by a tutor registered with the NBSCCCI
  at a date a time that suits the trainer.

### State Inquiries

#### **Northern Ireland**

The Northern Ireland Historical Inquiry Team into Institutional Abuse have submitted their report to the First and Deputy First Minister in Northern Ireland. It is expected that the report will be made public on 20<sup>th</sup> January 2017.

#### **England, Scotland and Wales**

The Independent Inquiry into Child Sexual Abuse in England is investigating whether public bodies and other non-state institutions in England and Wales have taken seriously their responsibility to protect children from sexual abuse, and make recommendations for change in the future. Child Safeguarding practice in some Church Bodies within the Catholic Church is being investigated as part of this Inquiry.

#### Australia

The Royal Commission in Australia will hear evidence on Catholic Church practice from Ireland in February 2017.

#### Republic of Ireland

Tusla have now completed their Ferns Review report of Religious Congregations and Orders and will produce their report in the coming weeks.

## Working with Respondents

Initial discussions are about to take place with Association of Catholic Priests (ACP) and other stakeholders to develop better practice in support those accused of child abuse. The NBSCCCI's position is clear in that offering support to accused priests and religious is also a way of ensuring the safety of children. ### **Practice Issues**

## Visiting Clerics or Visiting Persons in Any Form of Consecrated Life Ministering at Shrines, National Shrines and International Shrines

#### **Definitions**

A Shrine is a Catholic church or other sacred place which with the approval of the local ordinary is by reason of special devotion frequented by the faithful as pilgrims (Canon 1230).

To be considered a National Shrine the approval of the National Irish Episcopal Conference is necessary. For it to be described as International, the approval of the Holy See is necessary (Canon 1231).

### For Visiting Clerics or those in any form of consecrated life, ministering in Shrines and National Shrines in Ireland

Prior to the visit, where there is an intention to engage in public ministry, all visiting clerics and those in any form of consecrated life must follow Guidance 1.1C. In particular:

- If the visiting cleric is ministering at a one-off event which is not considered a regulated activity (as de ned in Guidance 1.1B) the cleric must provide his celebret for inspection by the parish priest or duly delegated person and this should be noted beside the visitors signature in the register.
- If the ministry is for a short term basis, the visiting cleric must follow the requirements set out in Guidance 1.1C.
- If the ministry is being carried out by a non-ordinated religious then the guidance outlined in Guidance 1.1C must be followed.

#### Visiting Clerics celebrating or concelebrating Mass at Shrines outside Ireland

- If the Shrine is outside of Ireland all child safeguarding requirements of the organisation within which the ministry takes place must be followed, in accordance with Guidance 2.1J.
- The main celebrant must allocate responsibility for each cleric wishing to concelebrate to have their celebret cards checked to ensure they are in good standing.
- A cleric who is out of ministry due to child safeguarding concerns must not attempt to celebrate any sacrament in public while abroad.

### Reporting child protection suspicions, concerns, knowledge or allegations to An Garda Síochána

An Garda Síochána have clarified with the NBSCCCI that the telephone number of the Gardai National Protective Services Bureau **should only be used** when referring allegations against clerics or religious. If the allegation is related to a lay member of Church personnel or the allegation is about someone who is not a member of Church personnel, then the local Garda station number should be used.
